Item :1	Through Circulation Approval of the EC on Resolution Nos. BC:16.12 of the 16 th Building Committee BC and FC:15.18.5 of the 15 th Finance Committee of the Vishwavidyalaya 1. The Standing Committee of the UGC has been scheduled on 30 August 2018 at New Delhi. It is for the information of the esteemed members of the EC that the approval of the Standing Committee of the UGC is mandatory for awarding new building construction works, as well as repair and maintenance works costing above Rs 75 lakhs. Following Procedure is being adopted. 2. UGC has conveyed the approval of Rs 20 crores to Dr. Harisingh Gour Vishwavidyalaya as a onetime additional grant under grant-in-aid Capital Assets for the Financial Year 2017-18, for the Repair and Maintenance of the Hostels and old Academic Buildings to be utilized before 31 March 2019. After allocation of the funds by the UGC to the University, the proposal with cost estimates was taken up in the 16 th Building Committee Meeting dated 06 June 2018, having three external members. Upon approval of the BC, these proposals were discussed and approved in the 15 th Finance Committee Meeting dated 15 June 2018. Finally these proposals are to be placed in the EC.
